Subject: Intimation under Regulation 30 of SEBI (Listing Obligations and Disclosures Requirements) Regulations, 2015 - Lapse of Convertible Warrants and Forfeiture of Subscription Amount of the said Convertible Warrants:

With reference to the captioned subject and in accordance with Regulation 30 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“Listing Regulations”), we wish to inform that the Company has not received the balance 75% of the warrant subscription amount from Mr. Ramesh, a non-promoter category warrant holder, for 6340 convertible warrants held by him. Consequently, Mr. Ramesh has not exercised his right to convert these 6340 convertible warrants into equity shares within the stipulated eighteen-month period from the date of allotment i.e., on or before the October 06, 2024.

As per the terms and conditions of the issue, the 6340 unexercised convertible warrants have lapsed. Additionally, the upfront payment of 25% of the issue price, made in respect of these 6340 convertible warrants, has been forfeited by the Company due to the non-exercise of the convertible warrants within the stipulated warrant exercise period.
