He also gained global experience across myriad steel related input industries like Refractories, Ferro Alloys, Ores and Minerals.

Mr. Bose propelled to become the CEO of a Tata group company (Sila Eastern Limited, Thailand) just at the age of 41 where he turned around the company, tripled its profits and made it a debt free dividend paying company.

With over 30 years of experience in the steel and related industry, Mr. Soumen Bose is a Champion in, Six Sigma in Japanese Quality Model, Malcolm Baldrige Model of Business Excellence, Self- Initiated Projects & Value Engineering.

During his tenure with the Tata Group, Mr. Bose was responsible for sales of Chrome Ore, Chrome Concentrate, High Carbon Ferro Chrome, High Carbon Ferro Manganese in India and discerning international customers in Japan, South Korea and China. He Brought about a paradigm shift in pricing of Chrome Ore by entering into a formula based pricing with competitor, opened up and maintained warehouses for JIT supplies and brought in the novel idea of moving consumables by CONCOR rakes when road freight became prohibitively expensive. He organised the retail initiative to get into newer, low volume but high profit contribution markets. 
