We are pleased to present the report on the Postal Ballot conducted by M/s. Hariom Pipe Industries Limited ("the Company") seeking consent of its Members for the Special Resolution(s) as contained in the Notice of Postal Ballot dated March 06th 2025.

1. In terms of Sections 110 and 108 of the Companies Act, 2013, and all other applicable provisions, if any, of the Act read with Rules 20 and 22 of the Companies (Management and Administration) Rules, 2014, and extant Circulars issued by Ministry of Corporate Affairs in this regard, approval was sought out as SPECIAL RESOLUTION(S) for the following items.

1. Alteration of the Object Clause of the Memorandum of Association (MOA) of the Company:

2. Notice of the Postal Ballot.

2.1. The Company had hosted the Notice of Postal ballot on its website and the website of CDSL (e-voting Agency) on 10th March, 2025 and also intimated to BSE Limited and National Stock Exchange of India Limited on 10th March 2025.

2.2. Pursuant to Rule 20 and 22 of Companies (Management and Administration) Rules, 2014 and relevant MCA circulars, Notice was published on 11th March 2025 in Business Line (All India Edition), and in Surya (Telangana Edition), in regional language.

2.3. The Company has informed that, on the basis of the Register of Members and the List of Beneficial Owners made available by the Depositories viz., National Securities Depository Limited (NSDL) and Central Depository Services (India) Limited (CDSL), as on 28th February, 2025 ("the cut-off date"), the Company has completed sending of Postal Ballot Notice through E-Mail on 10th March, 2025, to 52,491 Members who had registered their email-ids with the Company / Depositories.

2.4 As informed to us, no member has registered/ updated his/her email-id with the Company pursuant to the Notice of Postal Ballot dated 06th March, 2025.





3. In terms of the aforesaid notice, Members were required to convey their assent or dissent, only through e-voting system, on e-voting platform provided by CDSL from Wednesday, 12th March, 2025 at 9.00 a.m. (IST) to Thursday, 10th April, 2025 at 5.00 p.m. (IST) both days inclusive.
4. 133 Members had cast their votes on the e-voting platform till 5:00 p.m. (IST) on Thursday, 10th April, 2025.
5. Members' demographic details and their voting rights were provided by CDSL (e-voting Agency).
6. After the scrutiny of the e-voting results, we report that the Special Resolution(s) as contained in the Notice of Postal Ballot dated 06th March 2025 has passed with requisite majority.
